Chairman, Vice Chairman, Treasurer Etc. Elections: Effective Immediately.

 An open discussion was held regarding the rearranging of the present committee members, and voted to a unanimous decision amongst all residents present.

- Stipulation that the initial term of Chairman and Vice Chairman will be for 12 months only.
- Re-signing of the Palace Fields Residents Association Constitution 2016, to be completed in the coming weeks.
- 5 Committee members to be elected in the coming months, to generally help out with the runnings of the estate, providing ideas and assistance.

"Taking in Charge" of the Estate:

- Correspondence between R'OC and Arlum Ltd., has occurred, to highlight, speed ramp retention, green area drainage, and replacement of trees where applicable.
- Phone call between R'OC and Arlum Ltd., where:

- 1. It was agreed that Areas 3, 6 and 9 green areas would be drained, by Rhatigans, to the best possible method possible, in the coming months.
- 2. It is Galway Co.Co. intention to remove the existing speed ramps, when the final course of tarmacadam is laid. Arlum Ltd. With Palace Fields Association request are discussing with Galway Co.Co. to retain the speed ramps in the interest of residential and public safety.
- 3. Final wearing course of tarmacadam to be laid targeting end of February/start of March, subject to feedback from Galway Co.Co., that all utilities are fully serviced and completed.

Speed Ramp Retention:

- The main motion on the agenda of the A.G.M. for discussion, was the "Taking in Charge" of the estate by Galway County Council, and the proposal to retain the existing speed ramps on the main thoroughfare through the estate in the interest of residential and public safety.
- After in-depth discussion, this motion was put to a vote, and by unanimous decision by the residents of the Palace Fields estate, present, the motion was carried that the ramps be retained on the main thoroughfare, as a speed calming measure, to ensure that existing residential and public safety, is maintained.
- A letter has been written and sent to Arlum Ltd, stating this result, to support the retention of the speed ramps by a majority vote of the Palace Fields Estate.

General Discussion:

- Financial Period of 01-May to 31st of April to be retained for financial year 2016 to 2017.
- €60 per annum yearly contribution to be retained, with two options of payment i.e. yearly €60, or half yearly 2x€30.
- Litter collection days to continue, in the interest of keeping the estate tidy and litter free. We need more people to help.....to act as a community.
- Discussed to involve the young people of the area, to look after the estate, and offer raffled spot prizes to participants as an incentive.....to be further discussed.
- Raffles to continue throughout the year, to reward those who are contributing towards the estate upkeep financially.
- Was highlighted, that when litter days are coming, or other such events in the estate, to use signs in the estate, facebook, and the website, to remind people that such events are coming good idea.
