## **Treasurers Report & General Financial Details:**

- Balance in main account as of 01-Oct-14 is €18,448.61, includes all expenditure to date. The balance of the social account is €389.46. The balance of the petty cash account is currently €87.50 with €47.00 for stamps and €20.00 for phone top up, having been spent in the last month
- WM reported that €600.00 had been collected since the last meeting. The total collection for this year is €10,950. This includes €220 in back payments from the last financial year 2013/14.
- The outgoings for October was €196.68 to Rennicks for signs, €57.00 for printing and €100.00 to petty cash.
- WM reported that the collections for our fourth financial year had started well. However, there are still contributions outstanding. Area 7 needs further collection, MG spoke with MK who will speak with LH. If help is required then this can be provided. Many thanks to all who have made their contributions.
- MG confirmed that Arlum owns house number 232. MG is to make enquiries as to why it was not included on the original list.

## **Dog Fouling Signs:**

MG reported that the dog fouling signs have been received as was voted and agreed to purchase in Octobers meeting..
 These are to be fixed in November. It was reported that there may be problems with the brackets supplied for fixing to the lamp posts, but this issue will be overcome.

## **Shrubbery at Entrance to the Estate:**

- WM, JF, SM, KK, RO'C, JJB and MG cleared the weeds and tidied up the front shrubbery to the estate last month. Thanks
  to all those who helped.
- New kerbing to be placed around the shrub beds, commencing 10-Nov-14.

#### **General Maintenance:**

- Garrett Fox to confirm that he has completed the cutting for this year due to the recent wet weather. He has also completed his two year contract.
- The tenders for the years 2015/16 are to be drawn up and sent out to three contractors. They will be sealed and opened at the AGM in February. MG asked if there were any clauses that needed amendment or adding.
- RO'C suggested that a clause be added to make sure that the grass was cut between the trees and posts. Even if it meant carrying out the task by hand.
- MG suggested that we include for fertilizing the green areas and verges. This was thought not to be necessary but fertilizing
  around all the trees between the first and second cuts was to be added with a potato based fertilizer. JJB mentioned that its
  a 7617 mix. It was agreed that these would be included.

• It was thought that the supply of good quality top soil and seed for the filling of the grass verges will have to be left until March 2015 due to soil and seed possibly being washed away, under present weather conditions.

## **Extra Shrubberies:**

- The Associations intention is to create new rockery and shrub beds to four areas on the estate as described in the last minutes. MG reported that a meeting had been set up in October, but had to be cancelled due to work commitments. MG to set up meeting with EM in November
- Existing shrubberies in the estate, are to be revamped also. Separate meeting to be held in November on this issue.

#### Park Entrance:

• The scheme to improve the pedestrian entrance of the park is still awaiting confirmation of a preplanning application meeting. All relevant correspondence has been placed on the Associations website. MG to chase.

### Litter:

- KK mentioned the litter on the estate after bins had been blown over recently. The residents concerned were not picking up the litter.
- Residents are asked to use straps to tie down wheelie bins as detailed in previous minutes, and to pick up their own litter from the bins......Your litter, is YOUR litter.

## **Smokeless Fuels:**

- JF asked if people could use smokeless coal on their fires, as some nights the air becomes thick with unpleasant smoke.
- WM mentioned that this is difficult without a bye-law in place such as in Galway.

#### **Tullinadaly Road:**

- SMD mentioned that the new concrete aprons formed in the carriageway of Tullinadaly road are dangerous. MG to write to Council for explanation.
- With the Tullinadaly carriageway way being so wide at the entrance to this estate, it was thought that a lane could be
  created with white lining to feed traffic turning left into the estate. Or the vision splay be improved by moving the estate road
  out and marking the road with hatched lining either side. MG to write to Council and raise these points.

#### **TEXT ALERT Security:**

- JJB reported that he had spoken to the Gardaí regarding the 'Text alert' scheme. He reported that the Gardaí are awaiting other schemes to be set up including rural Community Watch schemes. All of the schemes will then be launched together.
- JJB reported that this item was as last minutes.
